

1. WORKING ON-SITE AT HONEYWELL FM&T/KC BANNISTER FACILITY -- FACILITY GUIDELINES/REQUIREMENTS (Clause G-48.1) (December 2021)

The Buyer operates this facility under prime contract with the DOE, National Nuclear Security Administration (NNSA). Certain guidelines and/or requirements apply to the performance of work on-site at this plant.

U. S. Citizenship: Seller's personnel must be a U.S. citizen or have prior security approval to enter the Buyer's facility.

Limited Access: Seller's personnel shall have limited access to the Buyer's plant. Access shall be limited by issuance of a visitor's badge and escorting procedures. Badges are to be worn in full view on the left side of the body between the shoulder and the waist with the badge identification label exposed. Escorting shall be provided by Security Officers or Buyer's administrative personnel, depending on the nature of the work and the location of work (inside or outside Buyer's plant).

Seller Access: Seller's personnel shall enter the facility at Post 19 Northeast Gate.

- Entering the Facility: If the Protective Force Officer is not available at the Gate, the Seller's personnel shall call (816) 361-6295 to have a Protective Force Officer dispatched.
- Exiting the Facility: Seller's personnel shall exit the facility at Post 19 Northeast Gate. If the Protective Force Officer is not available at the Gate, the Seller's personnel shall call (816) 361-6295 to have a Protective Force Officer dispatched.

Security: Seller's personnel shall comply with all security policies, procedures and requirements as communicated through plant orientation or training.

Access Suitability Screening: Seller's personnel being submitted for an 'L' or 'Q' security clearance must first successfully pass the Buyer's Access Suitability Screening.

Items Not Allowed in Buyer's Plant (including all support buildings) unless provisions have been made through Security:

- Firearms, explosives, incendiary devices and dangerous material capable of causing property damage or personal injury
- Binoculars, telescopes, periscopes and any other optical device which allows viewing of objects from a distance
- Illegal drugs, drug paraphernalia, controlled substances, and alcohol (open or unopened containers)
- Pets
- Children under 18 years of age
- Other items prohibited by law

Bringing Chemicals On-Site: No chemicals/materials are permitted to be brought on-site that contain, either as a pure chemical or mixture ingredient, a listed Extremely Hazardous Substance (EHS) (40 CFR Part 355 Appendix B) without written approval from the Honeywell Health, Safety, and Environmental (HS&E) organization. Additionally, NO chemicals/materials are permitted to be brought on-site for which a Safety Data Sheet is required in excess of 10,000 lbs without written approval from HS&E.

SMOKING: THIS IS A TOBACCO FREE PLANT. TOBACCO IS NOT PERMITTED ON THE PREMISES.
